	emergency). If a player fails to meet #2, the Team Liaison will speak to the VP Hockey Ops and the player shall be considered as withdrawn from the tryout process. The result shall also be communicated to HEO Minor (the outcome can potentially weigh in to the player's release and transfer to another AA team). Or All tryout sessions are mandatory. All absences must be reported to the Team Liaison or the player may will be considered as having withdrawn from tryouts. The GRMHA Board of Directors may reconsider allowing a player to continue in tryouts after missing a mandatory tryout without advance notice and prior written approval in exceptional and unforeseen situations only. In situations where an absence is not reported a sub-committee comprised of Board members who do not have players participating at that age group will convene and make a decision within 24 hours on whether the player can continue in tryouts.
